



Dams Sector Web-Based Training Courses

Training provides the opportunity to continue learning state-of-practice methods aimed at enhancing protection and resilience capabilities. Recognizing the importance of continued training, the Dams Sector developed a series of three Web-based training courses.

Background

The great diversity of the Nation's critical infrastructure provides for significant physical and economic resilience in the face of terrorist attacks, natural disasters, or other emergencies. However, this vast and diverse aggregation of highly interconnected assets, systems, and networks may also present an attractive array of targets to domestic and international terrorists and magnify greatly the potential for cascading failure in the wake of catastrophic natural or manmade disasters. Failure or disruption of the Nation's critical infrastructure can threaten national security, result in mass casualties, weaken the economy, and damage public morale and confidence.

Improvements in protection and resilience of the Nation's dams and levees can make it more difficult for terrorists to launch destructive attacks, as well as lessen the impact of any attack or other disaster that does occur and provide greater resiliency in response and recovery. Dam and levee stakeholders have decades of experience planning for and responding to natural disasters as well as operational failure and disruption.

To ensure that dam and levee stakeholders have access to the knowledge required to enhance protection and resilience at their respective facilities, the Dams Sector developed a series of Web-based independent study (IS) training

courses to effectively provide information pertaining to security vulnerabilities, enhance the ability to assess risks to facilities, support the implementation of effective protective programs, and improve incident response capabilities within an all-hazards framework.

Courses

IS-870 Dams Sector: Crisis Management

This module addresses crisis management activities as an important component of an overall risk management program, and provides dam and levee stakeholders with recommendations to assist in the development of various plans focused on enhancing preparedness, protection, recovery, and resilience capabilities. The training course describes the purpose and basic elements of emergency action plans, recovery plans, and continuity plans; and addresses the basic elements of an effective exercise program.

IS-871 Dams Sector: Security Awareness

This module provides information to enhance the ability to identify security concerns, coordinate proper response, and establish effective partnerships with local law enforcement and first responder communities. The training course describes common security vulnerabilities; potential indicators of threats; surveillance detection; and reporting of incidents and suspicious activities.

This module addresses protective measures related to physical, cyber, and human elements, and describes the importance of these measures as components of an overall risk management program. The training course describes the basic elements of the risk management model, and discusses the steps required to develop and implement an effective protective program.
